

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.thelemonaidnetwork.com and Pops Spedster And Company and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Pops Spedster And Company include www.thelemonaidnetwork.com, Pops Spedster, The Lemon Aid Network and www.thelemonaidnetwork.com. Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Pops Spedster may collect personally identifiable information, such as your:
